Village sets deadlines for Sanctuary deal

Salado aldermen directed staff to "negotiate and prepare an engineer's contract for consideration at the next meeting for services to establish the Village's Certificate of Convenience and Necessity Service Area for a wastewater system."

The board voted unanimously Sept. 3 for the first of three motions concerning the wastewater treatment plant and the agreements between the Village and The Sanctuary, LLC.

They also voted unanimously for the second motion made by Frank Coachman to direct the Village Administrator to "contact a professional to pursue a contract for property within the specifications by the Village's wastewater engineering firm for the purpose of acquiring a wastewater treatment plant site, such recommendations for acquisition of a specific site to be brought forth to the BOA as soon as practically possible. The property should be no less than 8 acres."

The board voted 4-1 for to amend the Wastewater Services Agreement and Donation Agreement that were signed by Billie Hanks, Jr. Sept. 2 in several ways, both minor and major in nature. Coachman gave the motion, which had 13 parts to it, including strict deadlines and which received a second from Michael Mc-Dougal. Coachman, Mc-Dougal, Fred Brown and David Williams made the motion. Amber Preston-Dankert voted against.

Sept. 8 for the Sanctuary to "provide the amended Wastewater Agreement, amended Donation Agreement, the Public Improvement District agreement and an Economic Development Agreement, along with all supporting exhibits" to the Village.

The Village Board of Aldermen will meet in workshop session on Sept. 10 to discuss those documents, if they are received. The amended agreement requires that the workshop session "will be held with Sanctuary officials present or in attendance via video conference to negotiate the final version of all documents."

Following that meeting, the Board of Aldermen will hold a public hearing regarding all of the agreements with Sanctuary, LLC on Sept. 17. The amended agreement from the Village required "All signatories from Sanctuary, LLC must be present to finalize the agreements with the Village of Salado."

Other points of change and clarification within the amendment by the Village include these:

• "The land donation location and bounds for the purpose of building the Salado Wastewater Treatment Plant must meet the required stipulations of the current and nonamended TPDES Permit No. WQ0014898001 which states "north of the intersection of Shepard Drive and Farm-to-Market Road 2268, approximately 2,000 feet north from the end of Shepard Drive in Bell County Texas 76571."

• "Sanctuary, LLC shall make notification to the Commission and apply for permit transfer to the Application Review and Processing Team of the Water Quality Division of TCEQ within 48 hours of the execution of all related documents to these agreement."

• "Sanctuary, LLC will bear all expense related to extending or connecting to the Wastewater treatment plant and/or the discharge line."

• "All references to eminent domain requirements of the Village are to be removed from the documents."

• "Section 4.8 Wastewater Effluent Matters; Subsection (a) shall be amended to at no cost, for a period no longer than the length of the Public Improvement District taxing period."

• The service availability date will be two years from the execution date of all documents.

• "The Village reserves the right to choose the design and engineering firms for the construction of the Village System, including the wastewater plant and system funded by the bonds secured for this purpose." Finally, references to Sanctuary LP must correctly reflect Sanctuary, LLC and all documents must be edited to be sure that section numbers and letters flow correctly.3

Salado will participate in prescription take-back

Salado Police Department will participate in the 10th National Prescription Drug Take-Back initiative 10 a.m.-2 p.m. Sept. 26.

According to Salado Police Chief Jack Hensley, local residents can return their unwanted, unneeded, or expired prescription drugs for safe disposal.

Police will accept the prescription drugs at the Salado Police Department located just north of the Village Municipal Build ing

will take place on Sept. 12.

The National Prescription Drug Take-Back addresses a vital public safety and public health issue.

Many Americans are not aware that medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse.

Rates of prescription drug abuse in the U.S. are at alarming rates, as are the number of accidental

Americans do not know how to properly dispose of their unused medicine, often flushing them down the toilet or throwing them away - both potential safety and health hazards.

"Prescription drug abuse is a huge problem and this is a great opportunity for folks around the country to help reduce the threat," Rosenberg said. "Please clean out your medicine cabinet and make your home safe from drug theft and abuse." In the previous nine Take-Back events nationwide from 2010-2014, 4,823,251 pounds, or 2,411 tons of drugs were collected.

Village budget hearings set Sept. 10, 24

Salado aldermen will conduct a public hearing Sept. 10 at 6:30 p.m. on the proposed 2015-16 general operating budget and proposed tax rate of \$0.3395 per \$100 valuation.

The board will adopt the budget and tax rate on Sept. 24, following the second public hearing on the matter.

The total proposed tax rate is just below the rollback rate of \$0.3396.

The general operating budget will have total revenues of \$1,057,300. There will be \$231,704.67 paid in debt service. The proposed general operating budget has \$29 in revenue more than expenses. The current budget is at a \$427,000 deficit as adopted.

The hotel/motel budget will have revenues of \$229,860, plus a budgeted \$97,400 in revenues from the Salado Chamber of Commerce. The hotel/motel budget calls for a deficit of some \$26,000 for next year. The current year hotel/motel budget had a deficit of more than \$50,000.

Residents sound off on deer

"I will not stop chopping apples to feed to the deer on my back porch, becasue it is my right to do what I want on my property," said one Salado resident who admitted that she has an "addiction to feeding apples to the deer.

"We think we are helping them, but we are not," said another Salado resident who confessed to being what she called a "reformed deer feeder." She added that feeding deer corn was akin to "giving your child a Snickers bar" every day for every meal when it can lead to serious health problems.

Salado aldermen heard from several residents Sept. 3 who are on opposite sides of the fence of the issue of the population of white tail deer in Salado. Residents took to the public comment portion of the meeting to talk about the agenda item: "Discuss the Intentional Feeding and Management of Deer proposed ordinance."

While aldermen took no action on the item, they heard from residents about the feeding of deer and the hunting of deer in the city limits.

Joyce Pennington, the admitted feeder of apples to deer, told aldermen that the white tail deer in Salado are an attraction to residents of larger cities. "They love to come to Salado and enjoy what it is to be in the country," she said. "We have to figure out a way to manage the deer, but not endanger people through bow hunting."

Pennington said that she has 30 to 40 deer on her property that she feeds regularly, adding that "there is plenty of ground cover and plenty of plants on my property. I will volunteer to teach people what plants they can plant that the deer won't touch."

She said that if the Village is going to prohibit the feeding of deer with feeders or fruit, "then you better tell people not to water their yards because the deer will eat their grass and to dig up the flower beds because the deer love flowers and to trim their trees up at least six to eight feet because the deer will eat that high."

Charles Vickers said that when he moved to his house on Arrowhead three years ago, "there were two does that meandered down the street. Since then the

population has bloomed." On a recent walk around the neighborhood, he said he counted 52 deer in an area of less than 70 houses. "To me, that is an unsustainable situation. Our neighborhood exhibits a deer habitat that is totally exhausted," he said. "The ground covers are all gone, the smaller shrubs' foliage has disappeared and the foliage on the trees has been eaten as high as the deer can reach."

Kate Darnell, the admitted reformed feeder of deer, told aldermen that feeding deer corn is nutritionally a mistake. "The deer suffer from acidosis. They end up with deformed hooves and antlers and a host of other issues because the corn is nutritionally lacking, she said. "We are creating a dependency of the deer on manmade food," rather than the deer browsing for their food.

"There comes a time when it becomes a public health issue and safety issue," Darnell said about the overpopulation of deer. Bill Griffin, a resident

on Willow Creek for the past 17 years, agrees that it is "time to recognize that this is a problem Salado has." He added that Salado should follow what other communities have done that have been successful in controlling their suburban deer population.


Bill Doss referred aldermen and residents to a Texas Agrilife publication entitled "Managing Over-White-Tailed abundant Deer."

The 18-page reference from the Texas Aparks & Wildlife and Texas A&M Agrilife Extension service calculates that 10 does and 10 bucks can grow to a population of 769 in 10 years, assuming 50% fawn recruitment and 50% fawn mortality. This would degrade and exhaust habitat resources, according to the booklet.

Doss said that the deer population in Salado is estimated by Texas Parks and Wildlife biologists at 400 to 500 deer. "Each deer eats five to seven pounds per day. This will require at least 730,000 pounds of forage in one year.

"There is a tipping point," Doss said. He told aldermen about the habits of deer in his neighborhood. "They start the day by feeding in my backyard and then make their way down what we on Arrow-SEE WHITE TAIL, PAGE 6D





The GOP Field That Failed

The rise of Donald Trump is, in part, a function of a vacuum.

He is thriving in a Republican field that is large, talented and, so far, underwhelming. To paraphrase Bruce Springsteen, there's 17 candidates and nothing on. Except Donald Trump. Now, this has much to do with the media, and with Trump's unique qualities as a showman. He has the advantage of not caring about anything, apparently -- the facts, his reputation or, ultimately, winning the presidency. In consequence, he is a free man.

Yet no speech, no policy proposal, no argument, nothing from the other candidates has come close to capturing the imagination of voters, giving Trump the space to loom all the larger.

The weakness starts at the top, or what was supposed to be the top. Jeb



Trump doesn't necessarily do him any favors. Trump is such a forceful communicator that he comes off as some sort of throwback alpha male, whereas Bush is such an earnest wonk, he looks and sounds like a sensitive dad from a contemporary sitcom. It's like watching a WWE wrestler get a stern talking to from Ned Flanders.

Scott Walker, in contrast, had a surge early in the campaign. It dissipated over time when his limited preparation on national issues didn't match his outsized early press exposure. A so-so debate performance and the rise of Trump have continued his long fade to middle of the pack in the latest early state polling. Who could have predicted that the Midwestern candidate who tells stories about buying shirts for \$1 at Kohl's would have to play populist catch-up with the New York billionaire who travels by eponymous helicopter?

have been so high, he has been the least reactive to Trump. His campaign is still betting on the long game. It believes his talent will tell over time, but he doesn't have a natural geographic or ideological base.

Ted Cruz may be benefiting most from the Trump surge in his strategic positioning. He has a cogent theory of the case, which is that if he is nice to Trump -- and the other outsider candidates -- he eventually can inherent his supporters. This makes intuitive sense, although Cruz -- exceedingly careful in crafting his words and in calculating his interest -- is hardly a natural anti-politician.

It is still early, of course. The rules of gravity say Trump will come back down to earth. The media interest that is so intense now could burn out.

First DWI now requires ignition interlock to drive

A new law aimed at reducing repeat drunk driving offenses and saving lives on Texas roadways officially went into effect this month.

The law, signed by Governor Greg Abbott on June 19, requires all drunk driving offenders to install an ignition interlock on their vehicles to have their driving privileges restored following an arrest.

"MADD celebrates a much-needed improvement to Texas' drunk driving law as we head into the busy Labor Day weekend," said MADD National President Colleen Sheehey-Church. "As we remind everyone to Drive Sober or Get Pulled Over, we are relieved to add Texas to the growing list of states that have taken action to protect residents and visitors from the 100 percent preventable crime of drunk driving."

"Ensuring the safety of those on Texas' roadways is of utmost importance, which is why I was proud to sign this bill into law," said Governor Abbott. "The implementation of this law is an important step in creating a safer driving experience for all residents and visitors to the Lone Star State."

The new law requires the installation of an interlock for first-time offenders with a BAC of .08 or greater if they choose to drive following a DWI arrest during a license suspension. In his rendering of The Entrepreneur, sculptor Dean Kermit Allison gives us a revealing look at the self-made man in his relentless struggle to chisel himself from common stone. Blindfolded, The Entrepreneur must trust his instincts. He has no way of knowing how all this will turn out.

His face bears the marks of those who would stop him while he is in this most vulnerable stage. His hand is battered from misplaced strokes of the hammer, constant reminder of his own mistakes.

The exact position of the right leg has yet to be determined. The stone reveals two

distinct possibilities. To carve the leg forward and unbent at the knee would allow him to make use of a natural outcropping in the rock, perfectly positioned to accommodate the front half of the foot. To bend the knee would allow him to make use of another



natural rock formation that seems to offer a finished calf. The choice is the future, but it must be made. Whether or not to bend the knee is a choice that faces every entrepreneur.

As we continue to study this figure of bronze, it becomes obvious that the blindfold has been no impediment to his progress. His instinct has been remarkable. His enemies have not been able to stop him. He has overcome his mistakes.


The greatest danger is in his own hands. The angle of this chisel is far

too aggressive. It seems the rapid removal of such a volume of stone requires a chisel judged by many to be much to direct. Spectators continue to gather and watch with mounting interest . . . will his next stroke be the one that cuts him off at the knees?





Explanatory Statements for the November 3, 2015 Constitutional Amendment Election

Proposition Number 1 (SJR 1)

SJR 1 - Current law provides an exemption of \$15,000 from the ad valorem taxation for public school purposes of a residence homestead. The proposed amendment would increase this exemption to \$25,000, starting in the tax year beginning January 1, 2015. In order to reflect the increased exemption on the homestead of a person 65 years of age or older or a disabled person, the proposed amendment would provide a reduction to the current limitation on the total amount of ad valorem taxes. The proposed amendment would protect school districts from all or part of the revenue loss by authorizing an appropriation of funds according to formulas set by the legislature. In addition, the proposed amendment would authorize the legislature to prohibit a political subdivision from reducing or repealing a homestead exemption adopted by the political subdivision. Finally, the proposed amendment would prohibit the imposition of a tax on the conveyance of real property, but would not prohibit the imposition of a business tax measured by business activity, a tax on the production of minerals, a tax on the issuance of title insurance, or a change in the rate of a tax in existence on January 1.2016

The proposed amendment will appear on the ballot as follows: The constitutional amendment increasing the amount of the residence homestead exemption from ad valorem taxation for public school purposes from \$15,000 to \$25,000, providing for a reduction of the limitation on the total amount of ad valorem taxes that may be imposed for those purposes on the homestead of an elderly or disabled person to reflect the increased exemption authorizing amount, the legislature to prohibit a political subdivision that has adopted an optional residence homestead exemption from ad valorem taxation from reducing the amount of or repealing the

exemption, and prohibiting the enactment of a law that imposes a transfer tax on a transaction that conveys fee simple title to real property."

Proposition Number 2 (HJR 75)

HJR 75 - In 2011, voters approved a constitutional amendment to allow a surviving spouse of a 100 percent or totally disabled veteran an exemption from ad valorem taxation from all or part of the market value on the disabled veteran's residence homestead, as long as the surviving spouse had not remarried. The amendment did not apply to surviving spouses of veterans who died before 2011. This amendment would extend the exemption in such cases. The proposed amendment would apply only to ad valorem taxes imposed for a tax year beginning on or after January 1, 2016.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for an exemption from ad valorem taxation of all or part of the market value of the residence homestead of the surviving spouse of a 100 percent or totally disabled veteran who died before the law authorizing a residence homestead exemption for such a veteran took effect."

Proposition Number 3 (SJR 52)

SJR 52 proposes a constitutional amendment to repeal the requirement for the Comptroller of Public Accounts, the Commissioner of the General Land Office, the Attorney General, and any other officers elected statewide to reside in Austin, Texas, the state capital. Under current law, these statewide elected officers are required to reside in the capital of the State of Texas while in office. This amendment would not apply to the residency requirement for the Governor.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment repealing the requirement that state officers elected by voters statewide reside in the state capital."

Proposition Number 4 (HJR 73)

HJR 73 proposes a constitutional amendment that would grant the legislature the authority to pass statutes to allow a professional sports team charitable foundation to conduct charitable raffles under the terms and conditions imposed by general law. The laws passed under this authority may provide that the professional sports team charitable foundation may use proceeds from such charitable raffles to pay reasonable advertising, promotional, and administrative expenses. Any law enacted by this provision only applies to entities defined as professional sports team charitable foundations on January 1, 2016. Additionally, any law enacted by this provision may only allow charitable raffles to be conducted at games hosted at the home venue of the professional sports team associated with a professional sports team charitable foundation.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment authorizing the legislature to permit professional sports team charitable foundations to conduct charitable raffles."

Proposition Number 5

(SJR 17) SJR 17 proposes a constitutional amendment which would increase from 5,000 to 7,500 the maximum total population threshold of a county that is allowed to construct and maintain private roads as long as the county imposes a reasonable charge for the work.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to authorize counties with a population of 7,500 or less to perform private road construction and maintenance."

Proposition Number 6 (SJR 22)

SJR 22 proposes a constitutional amendment that would add the right to hunt, fish and harvest wildlife, including by use of traditional methods, in the Bill of Rights of the Texas Constitution. This right would be subject to laws and reculations intended to conserve and manage wildlife and to preserve the future of hunting and fishing. The proposed amendment would establish hunting and fishing as the preferred method of managing and controlling wildlife in Texas. The proposed amendment is not intended to affect any law or provision related to trespass, property rights or eminent domain, and would not prevent the legislature from authorizing a municipality to regulate the discharge of a firearm in a populated area in the interest of safety.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment recognizing the right of the people to hunt, fish, and harvest wildlife subject to laws that promote wildlife conservation."

Proposition Number 7 (SJR 5)

SJR 5 proposes a constitutional amendment to dedicate a portion of revenues from (1) the state sales and use tax, and (2) the tax imposed on the sale, use, or rental of a motor vehicle, to the State Highway Fund (SHF). Under current law, these funds would be deposited to the General Revenue Fund. Money deposited to the SHF is intended to be used only to construct, maintain, or acquire rights-of-way for public roadways other than toll roads; or to repay certain transportation-related debt.

The proposed amendment would appear on the ballot as follows: "The constitutional amendment dedicating certain sales and use tax revenue and motor vehicle sales, use, and rental tax revenue to the state highway fund to provide funding for nontolled roads and the reduction of certain transportation-related debt."

Christmas Gala will benefit local historical groups

The Ambrose and Cowan families, sixth generation owners of the Robertson Plantation and descendents of E.S.C. Robertson, are hosting a gala to benefit historic preservation 7 - 10 p.m. Dec. 3.

The Gala will benefit three Salado non-profit organizations: the Central Texas Area Museum, the Robertson Colony-Salado College Foundation, and the Salado Historical Society.

Tickets to the Robertson Plantation Gala are \$100 each and will include a home tour, hors d'oeuvres catered by the Range, and live music by

Pam Bland and Drs. Matt Rogers and Guy Okeson.

The host families are opening the entire Robertson home for the Gala event, including the private residence upstairs. Although the Robertson home is on the Salado Christmas Stroll home tour on December 3-4, only the downstairs rooms will be open for viewing at that time.

Colonel Elijah Sterling Clack (E.S.C.) Robertson was a Texas pioneer, patriot, soldier and jurist and was one of the founders of Salado College. E.S.C. and his wife Mary Elizabeth Robertson began building their Greek Revival style plantation home in 1856 and completed it in 1860. In addition to the twenty-two-room mansion, there are slave quarters and a family cemetery on the plantation grounds.





head Drive call 'restaurant row.'"

Restaurant row are stops in the yards of local residents who feed the deer daily.

Doss said that there is no evident support for hunting of the deer in the Village. "I don't think it is a workable solution. It is going to take something else."

He added that the "poster child for deer management is the Lakeway community on Lake Travis. They have been at it for 15 years and are having success."

Dr. Paul Cromwell told aldermen that "culling the herd by hunting is an egregious approach to getting the deer population down." He added that since he lives a block outside the city limits, "I will continue to feed them."

Almost every speaker said that they wanted some solution to the problem, most wanting to stop short of hunting the deer in the Village limits.

"You have one aldermen that has been telling everybody that they can kill the deer in their back yard," Hans Fields said. "That is true as long as it is in season, they have a license and they harvest the meat."

He added that "a lot of people feed the deer and love the deer and are certainly against bow hunting," The Managed Lands Deer Program is cited in the ordinance.

Jon McDurmitt said that the Village should carefully "manage the deer," and not "eliminate the deer." He said that many people come to visit Salado for the golf course and the creek and are happy to "see the deer."

Texas Parks & Wildlife works with communities to help them establish programs for managing deer populations through both lethal and non-lethal means.

Among the non-lethal approaches are making the landscape less "palatable" to deer through planting of deer-resistant plants and local regulations prohibiting the supplemental feeding of deer.

Supplemental feeding" cannot increase the carrying capacity of an area," according to the TP&W and Agrilife document. "It can however, artificially sustain populations above the acceptable limits of the natural habitat. In supplementally fed habitats, populations are vulnerable to volatile and unstable population growth and crashes."

The deer population has an impact on the ecology of an area, according to the document: " The impact of deer on a plant community has a cascading effect on deer and other animal populations. Invertebrates, reptiles, amphibians, birds, small and large mammals rely on diverse plant communities for food and cover, especially within those zones easily reached by foraging deer. Recovery of habitat affected by deer is impacted not just by short-term deer numbers, but also by the history and severity of over-browsing, soil conditions, and climate. Some studies indicate that drastic reductions in deer numbers have little effect on increasing plant diversity over the short-term and vegetation recovery may only occur through extended periods of low deer densities."

The booklet suggests these non-lethal approaches:

• Fencing of at least 8 feet and electric fences to keep deer off of properties.

• Unpalatable Landscape Plants that will cause deer to go to other areas for forage. Forrest W. Appleton in his article "Coping with the deer by the use of deer resistant plants" on the Aggie horticulture website lists these plants as being not so favored by deer.

Other deterrents could include visual, auditory or olfactory. Visual deterrents such as shiny pans, scarecrows, and other items can deter deer from an area, but the deer "quickly habituate to visual deterrent techniques

and become less scared of them," according to the Agrilife document.

Noise making devices can do the same, but may be troublesome to neighbors. Deer acclimate to noise as well in the long term.

Odors can be used to repel deer, according to Agrilife service. "Several commercial repellents are available, but their efficacy is questionable." Carnivore urines can help keep deer out and there are lists of commercial products to keep the deer away. Some suggest that spreading human hair on the ground near a garden will keep the deer out of it.

Agrilife service states in the resource document that Dogs are an effective deterrent for keeping deer out of your yard.

While these approaches may work in your own backyard, how does this affect the rest of the community when some neighbors may be throwing deer corn on the ground and others are throwing human hair on the ground to keep the deer away?

Community programs that are non-lethal could include Trap and Transport. However, these are expensive and are not always effective. The cost of Trap, Transport and Translocation of deer is estimated by Agrilife extension at \$150 to \$750 per deer. And not all the deer survive that are transported. According to "Survival and Movements of Translocated White-tailed Deer in South Texas" the "annual survival of all translocated deer was lower in the partially fenced property (64 percent) compared to the unfenced property (80 percent), but overall survival was similar to survival rates of adult native south Texas deer reported in previous studies (68-74 percent)."

Lakeway uses Trap and Transport as part of its deer management plan outlined in the Comprehensive Plan for the city. Since 1999, 1,613 deer have been

Fertility programs are even more expensive, estimated at between \$350 to \$1,100 per female.

Lethal approaches could include trap, transport and harvest approaches, which cost \$175 to \$350 per deer; individual hunting programs through Land Management plans that cost \$85 to \$300 per deer and sharpshooter programs that cost \$250 or more per deer.
